



Mountain Creek Sport Horses 2022 Parcival Breeding Contract

This contract is made by and between Elisha Massong of Mountain Creek Sport Horses (Stallion Manager) and _____ (Mare Owner/ Lessee) for the breeding of the mare _____, to the stallion know as Parcival (Stallion) for a term of two years ending September 15 2024 subject to the following terms and conditions:

Stallion fee is _____ CDN less any applicable credits or advances and be subject to any applicable taxes for Canadian Citizens (i.e. GST/HST). Collections required are \$300 (Could be subject to change at little to no notice). Fedex account number must be supplied prior to shipment of semen. All payments are to be made payable to Elisha Massong. The Stallion Manager guarantees viable semen at time of shipment.

1. Both parties agree that semen is provided for the named mare described in this contract only. Confirmation of insemination and conception of mare must be received by Stallion Manager before a signed breeding certificate will be released to Mare Owner/Lessee for foal's registration. Embryo transplants are prohibited without prior written permission from the Stallion Manager.
2. All fee's incurred by Mare Owner/ Lessee for the breeding of this mare are the responsibility of the Mare Owner/ Lessee, including any semen related expenses not otherwise specified, shipment expenses, as well as mare or foal expenses incurred. The cost of the shipment will be the responsibility of the Mare Owner/ Lessee either through FedEx number or other arrangement agreeable to the Stallion Manager.
3. Stallion Manager has the right of review and refusal of any mare which would not in the Stallion Manager's judgement be a compatible match. If found acceptable, confirmation of the mare's reservation to breed to the Stallion will be sent by the Stallion Manager to the Mare Owner/Lessee for the breeding season, which shall extend from March 15th until September 15th in any given calendar year. This will be entirely dependent on the weather and the stallion. Semen can be shipped outside of these dates totally at the discretion of the Stallion Manager. Addition fees may apply. Mare Owner/ Lessee understands and accepts that there will be times when the Stallion may not be available for collection. It is the Mare Owner/ Lessee responsibility to contact the Stallion Manager to determine the dates on which the stallion is available.
4. All semen orders must be received before 5pm Eastern Standard Time (Sunday to Thursday) and 48 hours prior to breeding the subject mare. Late requests may be honored only if collection is possible. PLEASE NOTE FEDEX PICKS UP AT 10AM. HOLIDAYS MAY EFFECT THE DAYS FEDEX IS ABLE TO PICK UP. Additional Fees may apply as agreed by the parties on rush/same day or having to direct ship/drive to the airport.
5. Mare Owner/Lessee shall not be entitled to a refund of fees paid. However, the Mare Owner/ Lessee may have the right to repeat service in the following breeding season. Should the subject mare become unbreedable and such condition is verified by a certificate of a qualified veterinarian, the Mare Owner/ Lessee may substitute another approved mare and a new contract must be signed for the substitute mare. At no time can this contract be sold or traded without the written authorization from Elisha Massong. A \$250 rebooking fee may apply to new 'owner' of the contract.
6. Mare Owner/Lessee warrants that mare is in sound breeding condition and agrees that mare will be bred under the supervision of a Veterinarian with considerable experience in artificial insemination as well as having access to standard equipment (e.g. ultrasound machine).

7. If the Stallion Owner is unable to supply semen for the stallion Parcival due to death or some infirmity as verified by a veterinarian, the Mare Owner/ Lessee will be entitled to receive one of frozen semen from the stallion Parcival as a replacement.

8. Live Foal Guarantee: A "Live Foal" is defined as a living offspring that has survived one year beyond the date of birth. Failing this and as verified by a qualified veterinarian, a repeat service will be provided at the Mare Owner/Lessee's expense including collection fee less the stallion fee. This clause will be valid until the end of the term of this agreement.

9. The laws of the Province of Ontario, Canada shall govern the terms of this agreement.
